

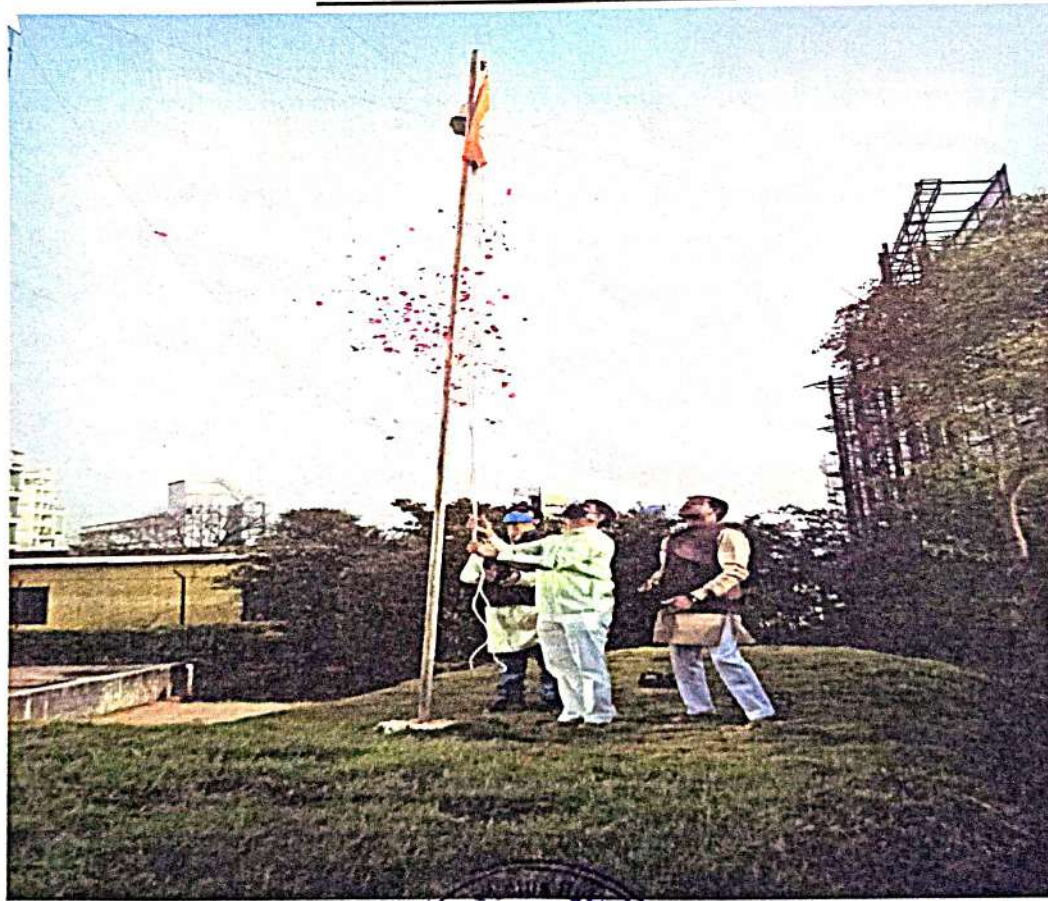

- As due to pandemic students were not allowed to join in offline mode so they attended event on online platform.



Indian Constitution contains 448 Articles in 25 parts and 12 Schedules and 105 amendments as of now.

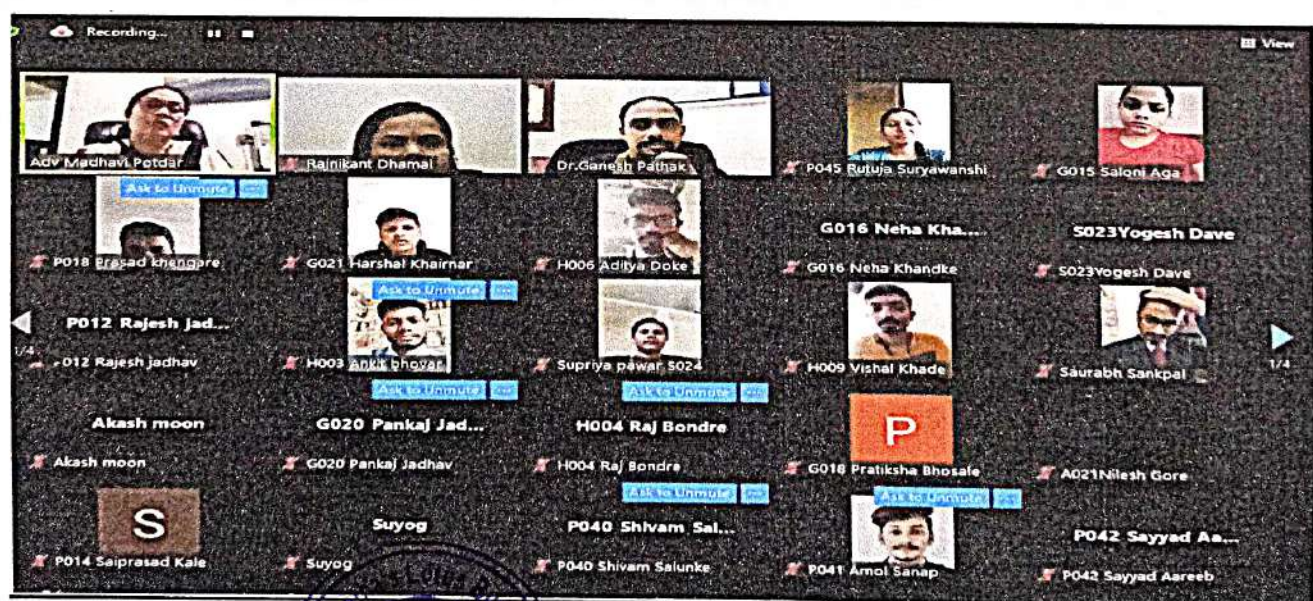
Corporate social responsibility is traditionally broken into four categories: environmental, philanthropic, ethical, and economic responsibility.

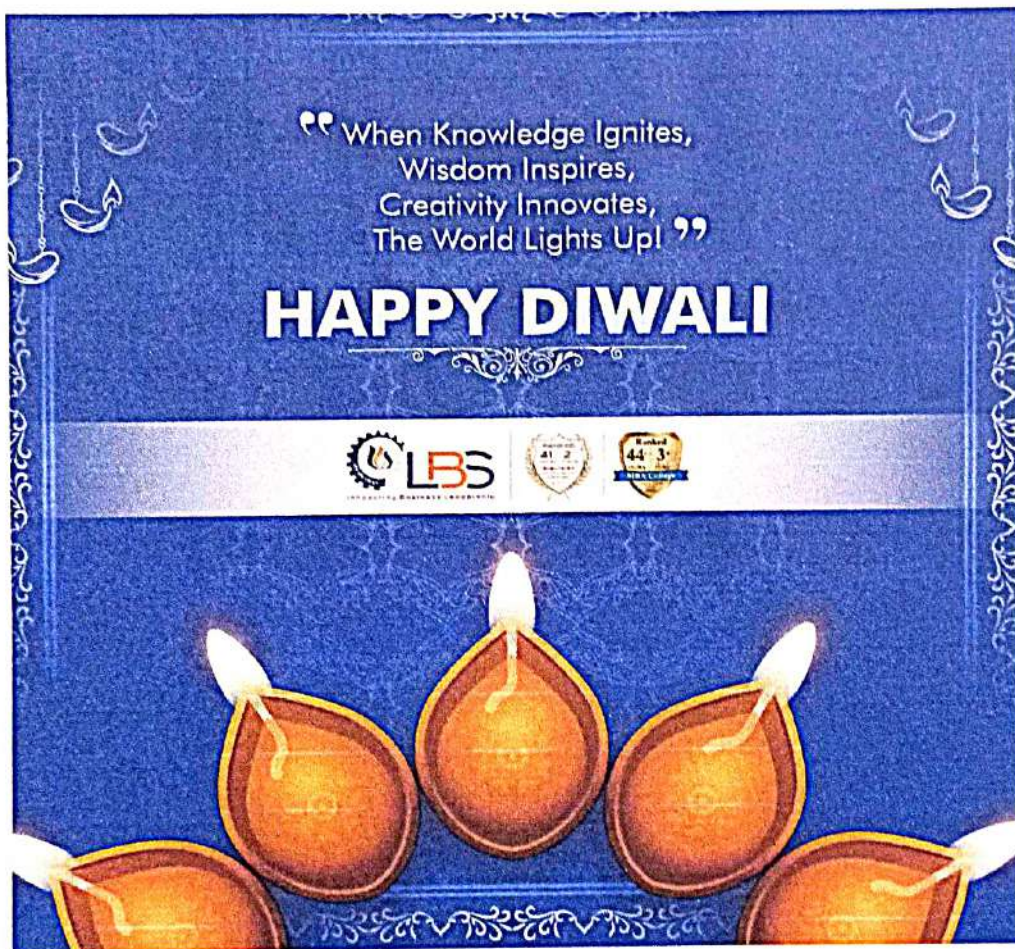
